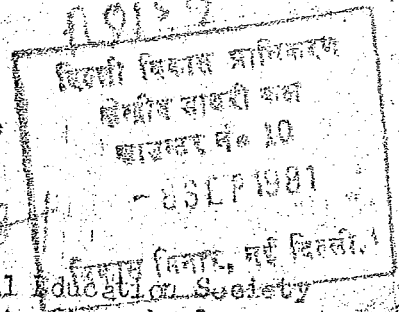

Sub:- Allotment of land to Universal Educational Society
7-Bhagwan Dass Road, New Delhi, for school purposes.

Sir,

I am directed to send herewith an application in a prescribed form alongwith enclosures received from the Universal Educational Society (Regd), Plot No.8, 7-Bhagwas Dass Road, New Delhi, for construction of school building at Patpar Ganj, Road in Nirman Vihar. The Society in question is registered under the Society's Registration Act, 1860, Delhi. The Constitution of the Society provides for opening Educational/Technical/Cultural Institutions. The society has obtained the prior permission of the Dte. for opening a Middle School in Trans Yamuna Area as per Rule 44 of the Delhi School Education Rule, 1973. It has already started a nursery cum-primary school at E-290 Nirman Vihar, Delhi-92 which is a newly developed colony and it is being habited rapidly.

The society has given an undertaking to abide by the rules and regulation of the Department for running a recognised school.

It is understood that a plot has been earmarked for school purposes in Nirman Vihar Co-operative House Building Society at Patpar Ganj Road, Delhi. It is recommended that the society may be allotted a plot measuring from .75 acre to 1 acre for construction of a new school building @ Rs. 3 lakhs per acre plus annual ground rent @ 2 1/2% of the premium for a Nursery cum-Primary School. As the school will be an unaided recognised private school. The prior approval of the Lt. Governor has been obtained for allotment of land in favour of the society.
